Applicants requesting a Permit to Perform Work Upon State Highways and/or submitting an Application & Permit for the Occupancy & Use of State Highway Right-of-Way (hereinafter, "Permit") where construction activities will occur are required to submit this Contractor's Certification of NPDES Compliance to the State of Hawaii Department of Transportation, Highways Division, Oahu District (HWY-O) along with the Construction BMP Checklist and a Written BMP Plan. The applicant is required to complete Parts I and II below and HWY-O personnel are required to complete Parts III and IV.
